2.0 TERMS OF ENGAGEMENT & ALLOWANCE:

2.1 Advisors shall be engaged under the Research & Development category and he will report to Director R&D in BEL.

2.2 The initial period of engagement shall be for One Year which may be extended year-on-year up to a maximum of 8 years (i.e. overall tenure of 8 years) or till the incumbent attains the age of 68 years, whichever is earlier.
