- 2. Candidate should be present on the interview date at reporting time and venue with all relevant documents in original with two photo copies for its verification. The candidates reporting after 12.00 P.M will not be allowed to appear in the verification.
- 3. The schedule is tentative and subject to change at any stage depending up on the availability of Selection Panel.
- 4. The Director, Mandya Institute of Medical Sciences, Mandya reserves the right to reschedule the above date, time and venue at any stage of walk-in-interview. Hence candidates are requested to visit institute's website (https://mims.karnataka.gov.in) regularly.

1. Important Notes:

- a) The above vacancy is provisional and subject to variation. The Director, MIMS Mandya reserves the right to vary the vacancy as per the Govt. of Karnataka rules/ circulars and requirements.
- b) All prescribed qualifications will be counted as on date of Walk-in-interview i.e. Date:17.01.2025.
- c) The employment will be purely on contractual basis and under no circumstances are linked to regular appointments and cannot be regularized at any stage. If the contract is not extended further, the same will lapse automatically.
- d) The emoluments will be consolidated in nature as determined by the competent authority.
- e) The appointment can be terminated by the competent authority any time before one year also, without assigning any reason thereof.
- f) Director, MIMS Mandya reserves the rights to cancel the advertisement at any point of time without prior notice.
- g) Selected candidate will be intimated by e.mail and by Indian Post.

2. No Objection Certificate:

Those who are working in Central/State Government/ Semi Government/ Autonomous body have to submit "No Objection Certificate" from their respective organization at the time of interview, failing which the candidature may be rejected.

- **3.** <u>Age Limit:</u> Age limit refers to completed age in years as on last date of submission of application i.e. the date of walk-in-interview. Age Limit: Above 18 years and below 45 years.
- 4. <u>Reservation</u>: As per the Reservation Policy of Government of Karnataka.
- 5. <u>Short Listing:</u> After scrutiny/verification of the documents as per eligibility criteria/ conditions, only eligible candidates may appear before the selection committee for interview. Candidates who report for walk-in- interview must bring duly filled printed copy (single side) of the application form. No Objection Certificate from the current employer (for Govt. employees only) and produce all relevant original documents in proof of details furnished in their application at the time of interview.

6. Selection criteria after the scrutiny the candidate will be shot listed based on marks, experience and personality test obtained (Marks-60%, Experience-20% and Personality test-20%) decided by the selection committee.

TERMS & CONDITIONS

- 1. The candidate who is already in government service shall submit 'No Objection Certificate' from the present employer at the time of Interview.
- 2. Canvassing or influencing of any kind will lead to disqualification.
- 3. The prescribed qualification is minimum and mere possessing the same does not entitle any candidate for selection.
- 4. The appointee shall not be granted any claim or right for regular appointment to any post of MIMS.
- 5. He/ She expected to conform to the rules of conduct and discipline as applicable to the institute employees.
- 6. The appointee shall not be entitled to any benefit like Provident Fund, Pension, Gratuity, Medical Attendance Treatment, Seniority, Promotion etc. or any other benefits available/ applicable to the Government Servants, appointed on regular basis.
- 7. The appointment can also be terminated at any time, on either side, by giving one month's notice or by paying one month's salary, without assigning any reason or failure to complete the period of three months to the satisfaction of competent authority. The appointee shall be on the whole-time appointment of the MIMS Mandya and shall not accept any other assignment, paid or otherwise and shall not engage him/ her in a private practice of any kind during the period of contract. The appointee shall perform the duties assigned to him/her. The competent authority reserves the right to assign any duty as and when required. No extra/additional allowances will be admissible in case of such assignment.
- 8. Leave entitlement of the appointee shall be governed as per the existing rules of the Institute for contractual employee.
- 9. The appointee shall not be entitled to avail any allowances/facilities being extended to the regular/permanent faculty members of the MIMS.
- 10. The candidate should not have been convicted by any Court of Law / criminal case disgualification for adverse character and antecedent.
- 11. In case any information given by declaration by the candidate is found to be false or if the candidate has willfully suppressed any material information relevant to this appointment, he/she will be liable to be removed from the service and any action taken as deemed fit by the appointing authority.
